RECAPITULATION

The following Amendments to the Constitution of Virginia received a favorable majority of the votes cast and became part of the Constitution on January 1, 1987:

QUESTION 1: Shall the Constitution of Virginia be amended to allow any registered voter, who has not voted in four years, to continue to be registered if he so requests in writing and still lives at the address listed on the registration records?

Amends Section 4 of Article II:

QUESTION 2: Shall the Constitution of Virginia be amended to allow government employees, except those who are elected or those who are employed by an elected official, to be appointed assistant voter registrars or officers of election?

Amends Section 8 of Article II:

FOR AGAINST 478,921 450,180

QUESTION 3: Shall the Constitution of Virginia be amended so that the Virginia Supreme Court may answer questions of state law certified to it by a federal court or the highest appellate court of another state?

Amends Section 1 of Article VI:

FOR AGAINST 709,745 201,116

QUESTION 4: Shall the Constitution of Virginia be amended so that the state may be given a right to appeal certain preliminary dismissals and exclusions of evidence in felony cases?
