

# Statement of the Whole Number of Votes Cast For and Against Certain Proposed Amendments to the Constitution of Virginia

At an election held on Tuesday, November 8, 1960

No. 1—QUESTION:

Shall sections one and two of Article XVII of the Constitution of Virginia be amended so as to permit an exemption for all members of the armed forces of the United States from the payment of poll tax and from registering as condition of right to vote and relief from the assessment and payment of such poll tax.

No. 2—QUESTION:

Shall sections one hundred ten, one hundred eighteen, one hundred nineteen and one hundred twenty of the Constitution of Virginia be amended so as to permit certain elected officials of one county or one city to serve as such officials in two or more counties, two or more cities or cities and counties, if a majority of the qualified voters of the political subdivision affected so decide, in an election held for the purpose.

No. 1—
