The following Amendments to the Constitution of Virginia received a favorable majority of the votes cast and became part of the Constitution on January 1, 1985:

QUESTION 1: Shall the Constitution of Virginia be amended so that members of local governing bodies can be elected or appointed to vacancies in the office of mayor or board chairman?

QUESTION 2: Shall the Constitution of Virginia be amended to require a balanced State budget?
